During my visit to Vijayapur District, it is brought to my notice that the benefit granted to several villagers for construction of toilets is not being utilized and defecation in open area is resorted to, thereby causing serious health hazards to the villagers.

This menace could not be possible unless the concerned officials at the village level are either party to the illegalities or guilty of omissions in not taking necessary steps against the beneficiaries. The Executive Officers of various Taluk Panchayath, who were present during the course of hearing of other cases, has been directed to prepare an <u>action plan</u> in respect of specific number of villages and initiate action against such of the beneficiaries who have misused the benefit and are not making use of the toilets and are indulging in defecation in open area.

Action shall also be instituted to prevent defecation in open area in the villages by providing appropriate toilet facility. Initial action plan in respect of <u>Ten Gram Panchayaths</u> of each Taluk shall be submitted on or before 26-02-2021.

The concerned Executive Officer shall also submit an year wise report as to how many families in the given villages have availed benefits from the Government for constructing toilets and out of them how many families have actually constructed toilets and how many families have been using them actually. If some of them are not actually using such toilets or have not actually put up / constructed them, what action has been initiated against them.

The Executive Officer shall also submit/state in the said report regarding the omission and commission of the Panchayath officials in that regard. The concerned Executive Officer shall submit a detailed report in this regard on or before 26/02/2021 failing which he shall appear before this authority on 02/03/2021 with appropriate explanation.
