- 1. During my visit to Belthangadi in Dakshina Kannada District, on 17.12.2020 it was brought to my notice that a portion of lake measuring 26 cents of Ujire lake(A) has been encroached by one Raveendra Oppanthaya by putting up barbed fencing and action is being taken to evict the said encroachment through Revenue Inspector and a report in this regard is submitted to SP, Karnataka Lokayukta, Mangalore, on 5.11.2020.
- 2. The Revenue Inspector Sri Patheesh.H.R., who was present before me has undertaken to take suitable action to prepare sketch of the encroached area and to evict encroachment. He requested for a reasonable time in view of ensuing Gram Panchayath elections and that after taking action, during January, 2021, he would submit report within a month thereafter.
- 3. Further, Sri Amanulla, Police Inspector, Karnataka Lokayukta, Mangalore shall submit a detailed report in this regard on or before 2.2.2021.


