During my visit to Belthangadi in Dakshina Kannada District, on 17.12.2020 it was brought to my notice that a portion of lakes measuring 10, 24, 40 and 30 cents respectively of Mundaje lake(A) and Mundaje Lake (B), Kaliya lake and Ulfe lake of Pilya village, have been encroached by several persons viz., Vasudeva Saphalya, Krishna Bhat S/o Gopalakrishna Bhat, Abdul Khader and Chinnappa Gowda, Vittal Suvarna S/o Duja Poojari and action has been taken to evict the said encroachment through Revenue Inspector and a report in this regard is submitted to SP, Karnataka Lokayukta, Mangalore. However, there is no material placed to show that encroachment has been removed.
2. The Revenue Inspectors concerned who are present before me viz., Sri Pratheesh.H.R., (Mundaje lake), Sri Dayanand(Ulfe lake of Pilya Village), Sri Pavadappa Doddamani(Kaliya lake), undertake to take suitable action in the matter and to submit a report in this regard. The Tahsildar Sri J.Mahesh, also submitted that he would take suitable legal action to evict the encroachment and submit a report in this regard.






