**REPORT U/S 12(1) OF THE KARNATAKA LOKAYUKTA ACT,
1984**

Sub: Eviction of the persons who are in
unauthorized possession of Sy.
Nos.28/2, 28/3, 28/4 and 28/5 of
Manganahalli Village, Yeshavanthapura
Hobli, Bangalore North Taluk-reg.

Complainant Sri.Krishna.K s/o. K.S.Ramachandra Rao, No.6, 6th Main Road, 3rd Cross, Jnana Jyothi Nagar, Bangalore-560056 (hereinafter referred as Complainant) has filed complaint alleging that the Sy.No.28 of the Manganahalli Village, Yeshavanthapura Hobli, Bangalore North Taluk is measuring 7 acres 25 guntas. Out of it, 2 acres 15 guntas has been granted in favour of Thimmaiah in case No.11BS7/74 and one acre has been granted in the name of Govindappa in case No.7/74-75. In respect of remaining land, during 2005-06, on the basis of the order of the Asst.Director of Land Records, Sy.No.28 has been phoded as 28/1 to 28/5 in the names of different persons by creating false documents.

2. Tahsildar, Bangalore North Taluk has submitted comments enclosing the copy of report of Revenue Inspector stating that permission has been sought from the Dy. Commissioner to


register the cases u/s 13(3) of Land Revenue Act and hold enquiry.

3. Dy.Commissioner, Bangalore Urban District was called upon to submit report on the Complaint. Dy. Commissioner has submitted reply stating that it is decided to hold enquiry in the matter and enquiry has been fixed on 31.10.2014. That the case has been transferred on 3.2.2015 to Spl.D.C.-1 for deciding the case and he has issued notice to the parties fixing the date for enquiry on 18.4.2016.

5. The report of the Tahsildar dt:05.11.2011 submitted to the Dy.Commissioner disclose that there are no records for having granted land in favour of (1) Smt.Channamma, 2) Sri.Maregowda, (3)Sri.Ramakka,4) Sri.Krishnappa and 5)Sri.Venkatanarasimhaiah and their names appear in RTC of Sy.Nos.28/1, 28/2, 28/3, 28/4 and 28/5 respectively from 2005-06 and permission has been requested to register cases against them u/s 136(3) of Karnataka Land Revenue Act to hold enquiry. Further, Spl.Dy.Commissioner in the letter dt: 4.4.2016 has stated that Notices have been issued to the parties fixing the date of enquiry on 18.4.2016.

6. Since the materials on record disclose that of (1) Smt.Channamma, 2) Sri.Maregowda, (3)Sri.Ramakka, 4) Sri.Krishnappa and 5)Sri.Venkatanarasimhaiah are in illegal possession of Sy.Nos. 28/1, 28/2, 28/3, 28/4 and 28/5 respectively, this report is made under Section 12(1) of the Karnataka Lokayukta Act to the Government to direct the concerned Competent Authorities to evict persons whose names are entered in the RTC illegally in respect of Sy.Nos. 28/1, 28/2, 28/3, 28/4 and 28/5 as stated above.

5. The Competent Authority shall take steps to implement this report within a period of six months from the date of this report and shall submit action taken report in this regard as provided under Section 12(2) of the Karnataka Lokayukta Act.
