**REPORT U/S 12(1) OF THE KARNATAKA LOKAYUKTA ACT,
1984**

Sub: For taking action to clear the building
situated in property No.233/1 and take
possession of land situated in property
No.233/1 belonging to Gabasavalagi
Grama Panchayath, Sindhagi Taluk,
Bijapur District -reg.

1. Complainant Sri. Babagowdashiraya Biradar, Gabasavalagi, Sindhagi Taluk, Bijapur District (hereinafter referred to as Complainant) has filed complaint against Respondent - G.S.Hadapad, the then Panchayath Development Officer, Gabasavalagi Grama Panchayath Sindhagi Taluk, Bijapur District alleging that Sri.Devalsabamulla has encroached over Grama Thana land of Gabasavalagi Grama Panchayath and he is constructing building in Grama Thana land and no action has been taken by the Respondent to prevent encroachment.

2. Executive Officer has submitted letter stating that one Davalsab Imamsab Mulla is residing in the house after

constructing house and the documents are also entered in his name.


3. Report was called for from Police Inspector, Karnataka Lokayukta, Bijapur and he has submitted report stating that he has obtained report of P.D.O. and the report of PDO is that the property is in the name of Davalsab Imamsab Mulla since 1999-2000 and the said land is Grama Thana land. That Executive Officer and PDO were directed to take possession of the property and submit report. But no action taken report has been received from them.

4. C.E.O, Z.P, Vijayapura was called upon to state the action taken to clear the encroachment and C.E.O. has submitted reply stating that he had directed the Executive Officer, Sindhagi Taluk Panchayath to submit report and Executive Officer, Taluk Panchayath, Sindhagi has submitted report.

5. On 6.5.2006 itself the Executive Officer , Sindhagi, Taluk Panchayath has written letter to the Secretary of Gabasavalagi Grama Panchayath to take action to stop construction with copy to Panchayath Extension Officer, Sindagi Taluk to take action on unauthorised construction and submit report. But No action is taken since 2009 to take possession of property No.233/1 of Gabasavalagi Village, Sindagi Taluk, Bijapur District belonging to Gabasavalagi Grama Panchayath from Imamsab Mulla by the

concerned officials. Therefore this report is made under Section 12(1) of the Karnataka Lokayukta Act to the Government to direct the concerned Competent Authorities to take possession of land belonging to Grama Panchayath in accordance with law.

6. The Competent Authority shall take steps to implement this report within a period of one month from the date of this report and shall submit action taken report in this regard as provided under Section 12(2) of the Karnataka Lokayukta Act.
