**REPORT UNDER SECTION 12(1) OF  
KARNATAKA LOKAYUKTA ACT, 1984**

Sub: Recommendation to redress the grievance of the complainant Smt. Shivabayi @ Shivakka, W/o Rama Mouli, Chadachana, Indi Taluk, Vijayapura District – reg.

On the complaint filed by Smt. Shivabayi @ Shivakka, W/o Rama Mouli, Chadachana, Indi Taluk, Vijayapura District (herein after referred to as complainant for short) against (1) Sri Basavaraj Ravoor, Revenue Inspector, Chadachana, Indi Taluk, Vijayapura District, Presently working in Indi, Indi Taluk, Vijayapura District (2) Sri Sunil Rathod, Village Accountant, Chadachana, Indi Taluk, Vijayapura District and (3) Sri Umesh Vital Biradar, Village Accountant, Havinal, Indi Taluk, Vijayapura District [hereinafter referred to as Respondents (1) to (3) respectively] alleging that her father was the owner of land in Sy.No.85/2 measuring 6 Acres 22 Guntas of Chadachana Village and Sy.No.211 measuring 18 Acres 20 Guntas in Havinal Village, Indi Taluk. After the death of complainant's father, the above lands came to the share of complainant, her mother, brothers and sisters. During the year 2015, on the basis of false watni patra prepared, the Respondents have changed the entries in RTC. When the complainant approached the Respondents, they have

given evasive answers. Investigation was taken up after invoking power vested u/s. 9 of Karnataka Lokayukta, 1984.


2. The 2<sup>nd</sup> Respondent has offered his comments stating that he was not working as Village Accountant during the relevant period. The 1<sup>st</sup> Respondent has offered comments that the complainant has executed release deed, which was notarized on 23/07/2015. On the basis of the said release deed, he has effected mutation after following the procedure.

3. The complainant has not relinquished her right in the above property by registered deed. Therefore, the Respondent could not have acted upon the notarized document.

4. Now recommendation is made under Section 12(1) of Karnataka Lokayukta Act to the Government to restore the name of the complainant Smt. Shivabayi @ Shivakka W/o Rama Mouli in RTC pertaining to the Survey No.85/2A measuring 6 Acres 22 Guntas of Chadachana Village and land in Sy.No.211 measuring 18 Acres 30 Guntas of Havinala Village in Indi Taluk, Vijapur District.

5. The Competent Authority is required to intimate u/s 12(2) of Karnataka Lokayukta Act, the action taken or proposed to be taken on the recommendation made u/s 12(1) of Karnataka Lokayukta Act, within three months from the date of receipt of this report.
