REPORT UNDER SECTION 12(1) OF THE KARNATAKA
LOKAYUKTA ACT, 1984

Sub:- Complaint of Sri Chandrashekara Degalamadi,
President of Shri Shivasharana Haralaiah Machigara
Samaja, Shahpur, Gulbarga District - Reg.

1. An investigation under Section 9 of the Karnataka Lokayukta Act was taken up on the basis of a complaint filed by Sri Chandrashekara Degalamadi, S/o. Shivappa Degalamadi, President, Shri Shivasharana Haralaiah Machigara Samaja, Shahpur 585 223, Gulbarga District (hereinafter referred to as Complainant) against (1) Sri M.A. Salima, KMAS, Retired Chief Officer, Town Municipal Council, Shahpur and (2) Sri Masood S/o. Ali, Retired Chief Officer, Town Municipal Council, Shahpur (hereinafter referred to as Respondents 1 and 2 respectively).
2. The complainant has alleged that within the limits of Shahpur Municipality, CA sites and places reserved for parks were allotted to several persons (in all 31 sites) and respondents are responsible for the same.

3. As per the records, following CA sites, places reserved for parks and other persons are allotted to several persons.


