## RECOMMENDATION

Sub:- Departmental inquiry against; Sri Ramesh Mala, the then Range Forest Officer, Social Forestry Range, Aland, Kalaburagi District (now expired) – Reg.

Ref:- 1) Govt. Order No. ಅಪಜೀ 12 ಅಇವಿ 2015, Bengaluru dated 5/2/2015.

- Nomination order No.UPLOK-1/DE/97/2015, Bengaluru dated 23/2/2015 of Upalokayukta-1, State of Karnataka, Bengaluru
- Report dated 4/2/2022 of Additional Registrar of Enquiries-13, Karnataka Lokayukta, Bengaluru

The Government by its order dated 5/2/2015 initiated the disciplinary proceedings against Sri Ramesh Mala, the then Range Forest Officer, Social Forestry Range, Aland, Kalaburagi District (hereinafter referred to as Delinquent Government Official, for short as DGO) and entrusted the Departmental Inquiry to this Institution.

2. This Institution by Nomination Order No.UPLOK-1/DE/97/2015, Bengaluru dated 23/2/2015 nominated Additional Registrar of Enquiries-4, Karnataka Lokayukta, Bengaluru, as the Inquiry Officer to frame charges and to conduct Departmental Inquiry against DGO for the alleged charge of misconduct, said to have been committed by him. Subsequently, by Order No. UPLOK-1&2/DE/Transfers/2018 dated 6/8/2018, the Addl. Registrar of Enquiries-13, Karnataka Lokayukta, Bengaluru was re-nominated as inquiry officer to conduct departmental inquiry against DGO.

3. The following charge was framed and issued against DGO Sri Ramesh Mala, the then Range Forest Officer, Social Forestry Range, Aland, Kalaburagi District (now expired).

"The DGO, Sri. Ramesh Mala while working as Range Forest Officer in Social Forestry of Aland Taluk in Gulbarga District - during 2006-07 and 2007-08 spent an amount of Rs.41,45,100/- under MGNREG Scheme by planting saplings on road sides of some villages and planting some saplings on road sides of some other villages and did not maintain the saplings planted on road sides of some villages and caused a loss of Rs.41,45,100/- to the Government Exchequer and thereby the DGO being a Government Servant failed to maintain absolute integrity besides devotion to duty and which act of yours is unbecoming of a Government Servant and thereby misconduct as enumerated U/R 3(1)(i) to (iii) of Karnataka Civil Service (Conduct) Rules 1966."

- 4. During the pendency of the inquiry, the DGO Sri Ramesh Mala, the then Range Forest Officer, Social Forestry Range, Aland, Kalaburagi District has died on 19/6/2021. Therefore the inquiry officer has recorded the abatement of disciplinary proceedings against DGO Sri Ramesh Mala.
- 5. It is hereby recommended to the Government to accept the report of Inquiry Officer and to record abatement of disciplinary proceedings against DGO Sri Ramesh Mala, the then Range Forest Officer, Social Forestry Range, Aland, Kalaburagi District, in view of his death on 19/6/2021.
- 6. Action taken in the matter shall be intimated to this Authority.
