Sri Shivaraju, Tahsildar, Bengaluru North Taluk is present. Smt Revati Kampli, ADLR, Bengaluru North Taluk, is present along with Sri Girish, Surveyor, Bengaluru North Taluk.

- 2. Smt Revati Kampli, ADLR submitted that, since, the lake area in question is within the city area, it does not falls within her jurisdiction to survey the lake in question.
- 3. It is also pointed out in the course of discussion that, in the Koliwad Committee report only survey No.8 measuring 3 acres16 guntas has been pointed out as lake area. It is pointed out by Sri Girish, Surveyor that the revenue records show that Sy.No.10 is a private property (Patta land) and there is no lake.

- 4. It is reported by the TAC that, since there is no cooperation by the ADLR of Bengaluru North Taluk, they were unable to conduct investigation and submit report. Tahsildar, North Taluk submitted that, he will give full cooperation to the TAC.
- Since, Smt Revati Kampli, ADLR submitted 5. that, since, the lake area in question is within the city area, it is not necessary for the TAC to conduct investigation. The ADLR, City Survey is directed to conduct survey of lake in question. The Tahsildar is directed to conduct an enquiry with regard to the status of the land and submit a report to DRE-3 by the next date of hearing. In the meanwhile, issue Environmental Officer, notice Senior to the Bengaluru City, he may examine the lake and submit report by the next date of hearing. notice to the BWSSB to file the status report by the next date of hearing. Issue notice to the complainant for his presence on the next date of hearing.

In this regard, a clarification would be sought from the AEE, BWSSB, South Division-2, Bengaluru.
