

### **ORDER**

The complaint filed by Sri.H.S.Doreswamy for rejuvenation of lakes was originally registered in No.Compt/LOK/BCD-2253/2017. Subsequently, I passed an order for splitting of that complaint into several complaints confining to each one of the lakes in respect of which grievance has been made by Sri.H.S.Doreswamy. Accordingly, the grievance in respect of Yelahanka (Puttenahalli) Lake has been registered in this complaint.

- 2. While dealing with the grievance in respect of all the lakes in my order dated 17-01-2018, so far as **Yelahanka (Puttenahalli) Lake** is concerned, at paragraph 16 of the order, I have observed as follows:-
  - "16. So far as Puttenahalli lake is concerned, it is pointed out on behalf of the Complainant that it falls under the jurisdiction of Karnataka Forest

further However, it is Department. pointed out that the concerned officer who incharge of this is the Deputy Conservator of Forest, Bengaluru Urban District. Though the notice has been served, nobody is present on behalf of Deputy Conservator of Forest (DCF). Fresh notice may be issued to the Deputy Conservator of Forests with a direction to submit report with regard to the steps taken to protect and rejuvenate the lake. They shall file the status report by the next date of hearing."

- 3. The order extracted above indicates that, this lake falls under the jurisdiction of Karnataka Forest Department. Notice of this proceedings has not been issued to the Forest Department and also to the respondent in this proceedings.
- 4. Sri Jaganatha Rao, DCF attached to the BBMP submits that, this lake has not been handed over to the BBMP and therefore the BBMP which has been impleaded as 1st respondent in this proceedings may be deleted. Sri Pubby Shetty submits that he has no objection to delete the BBMP who is respondent-1.

However, he pointed out that BWSSB which has been shown as 3<sup>rd</sup> respondent in the original complaint may be retained as party respondent in this complaint and the name of the BBMP may be deleted. He further pointed out that KSPCB is necessary party to this proceedings.

- 5. In the light of what is stated above, the respondent-1 i.e., Deputy Conservator of Forest, BBMP is directed to be deleted. The original 3rd respondent i.e., the Chairman, BWSSB is directed to be shown as 3rd respondent only by designation. In the place of original respondent-1, the Deputy Conservator of Forest, Bengaluru Urban District is directed to be impleded. The office to amend the cause title as stated above. The notice of this complaint shall be issued to all the respondents.
- 5. The respondents referred to above are directed to be file their comments/status report by the next date of hearing. It is necessary to point out that, though the DCF, Bengaluru Urban District was

served with the notice, he did not appear for the proceedings earlier on 17-01-2018.

- 7. Office to implead the Chairman, BWSSB as respondent in this complaint and issue notice of this complaint to him.
- 8. Communicate this order to the complainant and to the respondents forth with both by E-mail as well as by means of postal service.

### ORDER

Sri. N.R.Suresh, representing the Complainant Sri H.S.Doreswamy, is present along with Advocate Kum.Pooja Kini and others.

- 2. On behalf of Respondent-1, Sri. Chikkarajendra D.K, Assistant Conservator of Forest, Bengaluru North is present along with Sri. K. Ramesh, Range Forest Officer, Yelahanka. Sri. D.R.Kumaraswamy, Senior Environmental Officer (North), Karnataka State Pollution Control Board, Bengaluru is present on behalf of Respondent-2.
- 3. Though notice was served on Bengaluru Water Supply and Sewerage Board, who is shown as Respondent-3, none has appeared on behalf of BWSSB. No status report has been filed.
- 4. Sri. Chikkarajendra D.K, Asst. Conservator of Forests submitted that since the Respondent-1 is on leave, he prays for two weeks time to file status report with regard to

department reiuvenate steps taken by the to Puttenahalli Lake. He brought to my notice the project report prepared by him for rejuvenation of Puttenahalli also indicates that sum of Lake. The report Rs.1256.00 lakhs sanctioned by the Government is to be spent during the period of three years for the development of the lake, stage by stage, as set out in the draft project report prepared by him. He also submitted that the project report has to be examined by Respondent-1. Once the draft project report is examined by Respondent-1, the status report will be filed before me by the next date of hearing. The draft project report prepared, prima-facie, indicates that the steps have been taken by the Forest Department to rejuvenate the lake in the course of three years and for the said purpose, substantial amount has also been sanctioned by the State Government.

5. Sri. D.R.Kumaraswamy, submitted that there is no water in the lake in question and at present it is dry. It is pointed out that the lake has to be de-silted and therefore, the entire sewage water has been diverted to Raja Kaluve.

Sri. Chikkarajendra D.K, Assistant Conservator of Forest, submitted that the de-silting work has already been carried out and once the rain comes, the lake would likely to be filled with rain water and thereafter the lake will be properly maintained.

- 6. Sri. T.K.Puttaswamy and Sri. H.L.Miranda, representing Yelahanka Puttenahalli Lake Trust, submitted that the 10 mld STP installed near the lake has become totally defunct and the same is required to be made functional by the BWSSB at the earliest. He also pointed out several remedial measures to rejuvenate the lake.
- 7. In the light of the discussion that has taken place in the course of these proceedings, I am of the view, that the Complainant, the representatives of the Complainant, Sri. T.K.Puttaswamy and Sri H.L.Miranda representatives of Yelahanka Puttenahalli Lake Trust are reserved liberty to give a representation to all the Respondents in these proceedings i.e., Deputy Conservator of Forests, Karnataka State Pollution Control Board and Bengaluru Water Supply and Sewerage Board suggesting concrete proposals for

Miss. Rutu Hongal representing Sri. Doresway, Freedom Fighter is present.

Sri. Ramesh, Range Forest Officer is present on behalf of 1st respondent Deputy Conservator of Forest.

Though, the notice has been served, no one is present on behalf of BWSSB.

In the course of the discussion, it is brought to my notice that in spite of the observation made by me in my order dated 07-11-2018, no representation has been given to the authorities suggesting the problems of Yelahanka Lake and Bird Conservation Trust. In this connection it is useful to extract the observations made by me in paragraph 7 of my order dated 07-11-2018, which reads as hereunder.

On behalf of complainant Sri.H.S.Doreswamy, Sri Lakshmikanth and Professor K.S. Sunnguni are present. They have submitted a note dated 26-06-2019. It is useful to extract the same, which reads as hereunder:

- 2. Professor K.S. Sunnguni also produced a copy of the letter dated 20-06-2019 addressed by him to the Principal Secretary to Government, Transport Department, Government of Karnataka. It is useful to extract the same, which reads as hereunder:

"This is to bring to your kind notice that Yelahanka Puttenahalli bmtc bus depot has been leaving the busses' washed unclean water into the Puttenahlli lake. The oil and soap can be seen floating on the water. This has been going on for a long time. When we phoned the manager of the depot he said that he was leaving the water to an empty plot nearby. In that case the question is what has happened to the oil separator or the water treatment plant?

We request you to take action immediately..."

3. Professor K.S. Sunnguni submitted that, generally the Puttenahalli Lake is empty and certain other grievances are highlighted by him. Instead of going into those grievances, I am of the view, it would be in the interest of justice that, it is desirable Professor K.S.Sunnguni to give one representation setting out the details grievances to the (1) Forest Department, (2) BWSSB

and (3) Karnataka State Pollution Control Board. They are given two weeks time to give such representation. On receipt of such representation, the authorities referred to above are directed to examine the same and take remedial steps as permissible under law.

- On behalf of BWSSB Sri Devaraj, Additional Chief Engineer is present. He has made a statement that, they have already called for tender for the purpose construction of of MLD STP Puttenahalli Lake and after completion of the tender process, the work order will be issued and thereafter the completion of work would take at least two years According to him, after the completion of time. tender process, at least 18 months time is required for contractor to execute the work/completion of contract. He submits that, this is the minimum time required having regard to the nature of the work relating to construction of 8 MLD STP.
- 4. So far as the grievance of Prof. Sangunni is that, there will overflow of the sewage water to

Puttenahalli Lake and Yelahanka Lake is concerned, Forest Department is directed to examine the same and to take remedial steps.

5. On behalf of Karnataka State Pollution Control Board, Bengaluru, Sri Bhat, Law Officer and Sri D.R. Kumaraswamy, Senior Environmental Officer are present. They have submitted a status report dated 24-06-2019, which reads as hereunder:
