ORDER

The complaint filed by Sri.H.S.Doreswamy for rejuvenation of lakes was originally registered in No.Compt/LOK/BCD-2253/2017. Subsequently, I passed an order for splitting of that complaint into several complaints confining to each one of the lakes in respect of which grievance has been made by Sri.H.S.Doreswamy. Accordingly, the grievance in respect of **Thalaghattapura Lake** has been registered in this complaint.

2. Sri Jagannath is present on behalf of the 1st respondent. Though, on the last date of hearing a submission was made on behalf of the BBMP that they are not in a position to take up the work relating to **Talaghattapura Lake** on account of financial constraint, today Sri Jagannath submitted that the government is likely to release the funds for the development of Talaghattapura Lake. In that event the BBMP will take up the sewage diversion

work and cleaning of the lake immediately after calling for tenders as prescribed. He submits that the BBMP will be able to execute necessary works within about six months' time from the date of the order made regarding release of funds. The works herein below are required to be carried out by the BBMP:

- a) Diversion of sewage and cleaning of lake.
- b) Formation of walk path.
- c) Construction of police and security rooms.
- d) Lighting wherever is required.
- 3. Sri Rajashekar on behalf of BWSSB submitted that JICA fund is released for installation of pipelines running through 110 villages which has become part of the present BBMP. He submitted that the work has already been entrusted to the contractors and the work is required to completed within the period of three years as per the terms of the contract.

- 4. At this stage Sri Pabbi Shetty submitted that it is desirable for the BBMP to take a decision to execute necessary work after consulting the BWSSB and also in consultation with Karnataka State Pollution Control Board.
- 5. Having regard to the facts and circumstances of the case, in my view, it is desirable to convene a joint meeting with the officers of the BBMP (Lakes), KSPCB and the officers of BWSSB in the chambers of the Chief Engineer of the BBMP and to take a considered joint decision to execute necessary work to rejuvenation and maintenance of lake.
- 6. It is pointed out that lot of debris are being dumped inside the lake area and the garbages are burnt. Sri Jagannath to take immediate steps to prevent dumping of debris and burning of garbage near the lake area. He assures me that, they will immediately deploy sufficient number of Home Guards.

2. Sri. T. Jagannatha Rao, Deputy Conservator of Forest, Bruhat Bengaluru Mahanagara Palike is present. He has filed copy of the Proceedings of Meeting dated 07-11-2018 held with various officers under the Chairmanship of Chief Engineer (Lakes), Bruhat Bengaluru Mahanagara Palike. The said Meeting Proceedings reads as hereunder:

taken by Bruhat Bengaluru Mahanagara Palike in this regard.

On behalf of the complainant Sri H.S.Doraiswamy, Sri Lakshmikanth and Miss.Chaintanya are present along with Sri Babu. Sri Bhat, Law Officer is present along with Sri D.R.Kumaraswamy, Regional Senior Environmental Officer of Karnataka State Pollution Control Board (herein after for short KSPCB), Bengaluru. Sri Chandrashekar, Assistant Executive Engineer is present on behalf of the BWSSB. On behalf of the BMP Smt.Bupradha, Assistant Executive Engineer is present.

2) On behalf of the complainant, a letter dated 7.12.2018 is filed by Miss.Chaitanya setting out the issues that are required to be attended by the authorities concerned. It is useful to extract the said letter which reads as follows –

"Thalaghattapura Lake

Located in Hemmigepura ward (RR Nagar) covers an area of 19 acres 16 guntas. According to Koliwad Committee Report, 2 acres 29 guntas has been encroached.

Current Issues:

- The lake has a continuous inflow of untreated sewage that flows through multiple entries having resulted in frothing in the lake.
- This also has led to the excessive growth of water Hyacinths.
- Sight of the sewage flowing across the road (culvert), stench and mosquitoes adds to the woes.
- The lake has not been maintained, though it was developed by BDA and handed over to BBMP.
- Dumping of construction debris on the lake bed and increasing day by day.
- Dumping and burning of mixed waste (including hair from saloons)
- Open defaecation continues on the lake bed.

Solutions suggested:

- Complete the remaining fencing around the encroached area. Survey of the lake is yet to be completed and encroachment cleared.
- Address the sewage inlet issue by laying UGD / STP in the area on priority basis.
- Address the open defecation issue by building and maintaining public toilets
 around the area. The honourable Justice has already passed the order on
 this, which is to be implemented on priority.
- Ensure maintenance of the lake once the lake is completely rejuvenated."

- A copy of the said letter is also furnished to all the authorities. The authorities concerned may examine the issue raised and address the issues for the purpose of rejuvenation, protection and maintenance of lake.
- 4) Sri Chandrashekar, Assistant Executive Engineer, appearing on behalf of BWSSB submitted that they have taken-up the work of providing Under Ground Drainage system for 110 villages within the limits of BBMP and the same is planned for three years and work will be carried out in phased manner.
- Bengaluru submitted that since, now the State Government has sanctioned ₹5 crores for the development of the lake, the BBMP would take effective steps for the development of the lake with the assistance and co-operation of BWSSB and KSPCB. The said statement is placed on record. The Assistant Executive Engineer further submitted that since the Government has sanctioned the finance only on 1.2.2019, the BBMP has to take steps for tender process to entrust the work to the contractor and for other developmental activities.

According to her, it will take 6 to 8 months to rejuvenate and carry out necessary work for development of the lake.

- there is an encroachment in respect of the portion of the lake, it is necessary to get the lake resurveyed by the survey department to protect the said lake. In the light of the submission made, the Joint Director of Land Records, Bengaluru Urban District and the jurisdictional Tahsildar are directed to get the land, surveyed and point out the encroachment portion if any within a period of eight weeks from today.
- Records, Bengaluru South and the Tahsildar, Bengaluru South.

 They are directed to file the Status Report with regard to the survey conducted before the Lokayukta within a period of eight weeks time from today. After serving of the copy of the Status Report to the complainant and all the authorities. Such survey being done, the BBMP and the Tahsildar to take effective steps for eviction of the unauthorized encroachment

and file the Status Report. The authorities of BBMP, BWSSB and KSPCB is given ten weeks time to file their Status Report.

Ref: 1.Inspection of the Thalagatapura Tank on 20.09,2018.

With reference to the above subject, as per the direction of Hon'ble Lokayuktha, the Thalagatapura Tank area was inspected on 20.09.2018 and already submitted the detailed report to Hon'ble Lokayuktha office on 11.09.2018. This tank is located in Thalagatapura Tank village limits and comes under BBMP Hemgepura ward, Rajarajeswari Nagar Zone. The GPS reading of the tank is N-12° 52' 04.08" & E-77° 32' 06.90" respectively. This tank is developed by the BDA. But, at present this tank is not being used for any purpose. Fencing and earthen bund is provided all along the boundary of the tank. But, not maintained the tank. Hence, the tank bed is

completely covered by weeds and also water hyacinth was covered inside the lake water body. Further, at some portion of the tank, the fencing was found to be damaged. Lot of municipal solid waste is being disposed inside the tank bed area. As per the physical observation the catchment area the tank is part of Thalagatapura village limit, Ganagerepalya Adharsha layout. The untreated sewage from these areas is being entering into the tank through storm water drain. Hence, the tank is completely covered by weeds and water hyacinth. The tank water was not clear. Further, there is a Kalyani inside the lake and the kalyani is not visible since, the Kalayani area is completely filled with weeds & water hyacinth. Further, the water samples of the tank collected on 06.04.2017 and 20.09.2018 shows that, the analysis results are conforms to Class E & D Standards respectively. Copy of analysis reports enclosed for your kind reference."

- 4. In my earlier order dated 06-02-2019 at paragraph 7, I have observed as follows:
 - "7) Communicate this order to the Joint Director of Land Records, Bengaluru South and the Tahsildar, Bengaluru South. They are directed to file the Status Report with regard to the survey conducted before the Lokayukta within a period of eight weeks time from today. After serving of the copy of the Status Report to the complainant and all the authorities, on such survey being done, the BBMP and the Tahsildar to take effective steps for eviction of the unauthorized encroachment and file the Status Report. The authorities of BBMP, BWSSB and KSPCB is given ten weeks time to file their Status Report."

5. A status report dated 24-04-2019 is filed on behalf of the Assistant Director of Land Records, Bengaluru South Taluk, Bengaluru which reads as hereunder:

A Status Report dated 27.6.2019 has been filed on behalf of the Surveyor. It is useful to extract the same which reads as hereunder –

- 3) The report filed by the Surveyor extracted above indicates that lake has been surveyed and as per the Survey Report, out of total 19 acres and 16 guntas in all measuring 2 acres 29 guntas has been encroached upon. The details of which has been set out in survey report reads as follows –
- (1) In the possession of BDA 17 guntas.
- (2) Sri Nanjundaswamy owns 04 guntas
- (3) Smt.Rama Reddy Gowramma 08 guntas
- (4) In the occupation of others 02 acres
- 4) The above details of which have been set out, is as per the list enclosed. It is well settled that it is not permissible to anyone to encroach upon the lake area or the lake bed. Under





these circumstances, the Tahsildar, Bengaluru South is directed to take effective steps for removal of the encroachment of the lake area/lake bed in accordance with law. However, it is needless to mention, if some of the members are in settled possession over the years, the authorities of the State should consider providing them alternative sites. At this stage Sri Gajaraj and Sri Dhanjeya submitted that near the lake, there is some Government land around 12 acres at Thalaghatpura close to the lake and a layout could be formed or flat can be constructed for allotment of such of those poorer sections of the people, who are in unauthorized occupation of the lake area. In this connection, it is desirable that Sri Gajaraj gives representation to the Deputy Commissioner, Bengaluru Urban District and also to the Tahsildar, Bengaluru South Taluk and to the BBMP authorities for appropriate steps. On such representation being submitted by Sri Gajaraj, the Deputy Bengaluru Urban District, the Tahsildar, Commissioner, Bengaluru South Taluk and the BBMP to examine the representation and also find out the feasibility of making alternative arrangement for such of those persons who are in

unauthorized occupation of the lake area and who belong to the poorer section of the Society.

- 5) However, it is made clear that the observation made above would apply only to such of those persons who are poorer sections of the Society. The Tahsildar, Bengaluru South Taluk to submit the report with regard to the steps taken within four months from today.
- Bengaluru, submitted that the tender process for development of the lake has been completed and the papers have been forwarded to the Government for approval and as soon as the BBMP receives the approval, the Work Order will be executed to the successful contractor and BBMP would take effective steps to get the work executed as per the terms of the contract. She submitted that it may take about 11 months. She also submitted that though the fencing of the lake has been done, the same has been done excluding the encroachment portion. It is her further submission that once the encroachment is removed, steps will be taken to fence the area which is under



encroachment and it becomes the part of the lake area. The said submission is placed on record.

Communicate this Order to all the parties concerned. List this case on 12th December, 2019 at 3.00 p.m.

- 5. The report extracted above indicates that the Tahsildar is awaiting the direction from the Deputy Commissioner for removal of the encroachment. It is needless to point out that the concerned are required to comply with my earlier order for removal of the encroachment.
- 6. Sri Lakshmikanth submits that, the actual survey of the lake has not been done and the statement made on the last date of hearing i.e. on 09-07-2019 regarding survey relates to the survey conducted by the Koliwad Committee. The complainant is given 4 (four) weeks time to file his



objections before DRE-3 after serving a copy of the same to the concerned Deputy Commissioner and also to the concerned ADLR, Bengaluru South Taluk. The ADLR, Bengaluru South Taluk to file his response to the objection if any filed by the complainant within 4 (four) weeks thereafter. In the meanwhile, in terms of the order dated 25-04-2019 made by me, the necessary steps are to be taken for removal of the encroachment.

- 7. The presence of the Officers of the Pollution Control Board is dispensed with on the next date of hearing.

- 3. It is submitted by them that once the encroachment is removed, steps will be taken to fence the lake area. It is also submitted by them that subsequent to the order dated 12-12-2019 made by me, the officials of the Survey Department have not visited the area and surveyed the land. Neither the Tahsildar, Bengaluru South Taluk, Bengaluru is present from ADLR is present. In this connection, it is useful to extract the relevant portion of my order dated 12-12-2019, which reads as hereunder:
 - "6. Sri Lakshmikanth submits that, the actual survey of the lake has not been done and the





statement made on the last date of hearing i.e. on 09-07-2019 regarding survey relates to the survey conducted by the Koliwad Committee. The complainant is given 4 (four) weeks time to file his objections before DRE-3 after serving a copy of the same to the concerned Deputy Commissioner and also to the concerned ADLR, Bengaluru South Taluk. The ADLR, Bengaluru South Taluk to file his response to the objection if any filed by the complainant within 4 (four) weeks thereafter. In the meanwhile, in terms of the order dated 25-04-2019 made by me, the necessary steps are to be taken for removal of the encroachment."

4. The order extracted above indicates that, in terms of the order dated 25-04-2019, the steps were required to be taken for the removal of the encroachment. However, having regard to the facts and circumstances of the case, another eight weeks' time is granted to the Surveyor to survey the lake On such survey being carried out, the Tahsildar is required to remove the encroachment in accordance with law, if need be by taking necessary steps to rehabilitate the unauthorised occupants by providing them alternative sites per government schemes. I am sure, the Deputy

Commissioner and all other concerned will examine the matter and take appropriate decision on that behalf.
