ORDER

'The Hindu' – daily newspaper dated 16-12-2017 has published a news item highlighting the digging of the road/open drain which would result in risk to the life of the students.

2. It is useful to extract the said news item which reads as hereunder:

"Nearly a month after a portion of the 3rd Cross Road at NGEF Layout in Kasturi Nagar (next to Presidency School) was dug up for repair work related to the storm-water drain, hundreds of children have been forced to walk to the school in the little available space on the road.

The road, which many of the school buses use, is blocked to vehicular traffic with debris from the dug up portion lying about in mounds.

G.Thangadurai, Director, Presidency Group of Schools, said that he was worried about the safety of his students. "The place has been dug up and the debris dumped on the road leaving very little space for students

to walk. Also, there is no fencing around the work site and it is risky to walk. The drain has been left open," he said.

Stating that no work has been going on for many days now, Mr.Thangadurai said the BBMP should have given priority to this work considering it is being taken up right next to a school. "We tried reaching out to BBMP officials, but got no response. We were neither given prior notice nor have been told how long the work would take to complete," he said.

Shreekesh S, a Class 7 student, who cycles to school every day, said he has to be extra cautious as there are loose stone everywhere. "If a bike comes from the opposite direction, I have to ride on the rubble. It is very risky and dangerous, and my parents are worried," he said.

Meenakshi, Councillor of Ward No. 50, where the school is located, said there were some damage to the drain and repair work According taken up. been has Bruhat Bengaluru Chennakesava, Executive Assistant Palike Mahanagara Engineer, SWD, the repair was badly needed.

"The drain was old and there were lot of damages. We are building a concrete drain. The curing process takes 15 days......so we were unable to start work. It will start within two days and completed before the end of the month," he said".

3. The news item extracted above, indicates that the life of the members of the public and more particularly students life is exposed to serious risk and jeopardy. No doubt, the digging up of the road and open drain has drawn the attention of the Councillor of the Ward No.50 and Assistant Executive Engineer of BBMP, SWD. However, if the digging up of the road and open drain is not immediately attended to and if no steps are taken to protect the life of the members of the public and more particularly young students/children, it will result in serious injury to the life of the public and their safety.

4. The experience and the information received by me from various sources indicate that similar situation exists in other parts of Bengaluru City, which is highlighted in the news item referred to above. It is needless to point out that the BBMP and the concerned authorities like, BWSSB, BESCOM and BMRCL have an obligation when they are entrusted with the work which they are required to do, they are required to execute the work without undue delay and dig up the roads, if the

immediately required to be filled up and sufficient precautions are to be taken not to expose the members of the public to any risk and similar steps will also be required to be taken in respect of the open drains.

- 5. Therefore, in the light of what is stated above, I am of the view, it is in larger public interest to institute suomotu proceedings in exercise of the power conferred on me under Section 7(1) and 9 (3)(a) of the Karnataka Lokayukta Act, 1984. Accordingly, it is ordered. The office is directed to register this proceeding as suo-motu proceedings.
- 6. For the purpose of adjudication of the matter at issue, which is highlighted in the news item referred to above, it is necessary to issue notice to the following officers/officials:

The Respondents referred to above, that is each of the Chief Engineers and the concerned officers of BESCOM BWSSB, are directed to inspect the area which comes under their respective jurisdiction and submit a report with regard to the roads dug up within their jurisdiction and open drains available within their jurisdiction and steps taken by each one of them to fill up the roads which are dug up and cover the open drain and such other steps taken to protect the life of the public and protect the public interest. They shall submit the status report with reference to the matters referred to above within 10 weeks from the date of communication of this order.
- 8. However, in the mean while, it is needless to point out that the Respondent-1 and Chief Engineers of all
