ORDER

A petition (anonymous) dated Nil, stated to have been sent by Sri. A.K.Anjinappa, Sri. O. Sannabasappa and others alleging that one Sri. H.S.Madappa, First Division Assistant, Zilla Panchayat, Davanagere, though had retired on superannuation on 31-05-2017, he had refused to hand over charge to one Smt. R.G. Pooja, who was required to take charge, and he continued to discharge official duties as First Division Assistant in the said office till 01-08-2017 and while so functioning as First Division Assistant, he has misused official position, etc.

2. The allegations made in the said petition was referred to by me to the Additional Director General of Police, Karnataka Lokayukta, Bengaluru (hereinafter referred to as 'the ADGP' for short), to get an enquiry conducted by the Police of Karnataka Lokayukta, Davanagere. Accordingly, the ADGP referred the matter to the Superintendent of




Police, Karnataka Lokayukta, Davanagere, who conducted an enquiry, has sent his report dated 06/08-08-2017 inter-alia reporting that the allegations made in the complaint are prima-facie correct. In the report, it is stated that Sri. H.S.Madappa, First Division Assistant, Zilla Panchayat, Davanagere, though he had retired on 31-05-2017, he had failed to hand over charge to Smt. R.G.Pooja, First Division Assistant and continued to work even after attaining the age of superannuation on 31-05-2017 till 01-08-2017. It is further pointed out that, though Smt. R.G.Pooja, First Division Assistant, was required to take charge from Sri. H.S.Madappa, First Division Assistant, she has failed to take charge. It is also reported in this connection that Sri. G.S. Shadaksharappa, Deputy Secretary and Sri. H. Basavarajappa, Manager, Zilla Panchayat, Davanagere, have failed to take appropriate action to implement the order No. ಜಿಪಂದಾ:ಆ(2):ಸಿಆರ್:256/06-07/2017-18 dated 31-05-2017 passed by the Chief Executive Officer, Zilla Panchayat, Davanagere, notifying that Sri. H.S.Madappa, First Division



Assistant, Zilla Panchayat, Davanagere had attained the superannuation on 31-05-2017. The said report was considered by the ADGP and he has concurred with the report of the Superintendent of Police, Karnataka Lokayukta, Davanagere. Thereafter the report was examined by the Assistant Registrar of Legal Opinion-4 (ARLO-4), Karnataka Lokayukta, Bengaluru and he has submitted his report dated 24-01-2018. It is useful to extract the relevant portion of the report, which reads as hereunder:


3. When the said report was placed before me on 27-01-2018, I had directed the Registrar, Karnataka Lokayukta, Bengaluru, to examine and submit his views. Accordingly, the Registrar has submitted his note on 02-03-2018. It is suggested by the ARLO-4 and the Registrar that having regard to the report of the Superintendent of Police, Karnataka Lokayukta, Davanagere, it is a fit case for the Lokayukta to exercise suo-motu power and to investigate the matter further. The report submitted by the Superintendent of Police, Karnataka Lokayukta, Davanagere indicates that there is violation of Karnataka Civil Services (Conduct) Rules, 1966 by the concerned officials referred to above. The Registrar has opined that the Chief Executive Officer, Zilla



Panchayat, Davanagere may also be made party to this proceedings. It is useful to extract the said note which reads as hereunder:

“ It is reported that preliminary enquiry disclosed that different officers of Z.P., Davanagere, i.e., (i) Smt. Pooja, First Division Assistant, (ii) Sri. Basavarajappa H, Manager (Admn.), (iii) Sri G.S.Shadaksharappa, Dy.Secretary and (iv) Sri H.S.Madappa, First Division Assistant have violated the conduct rules as Smt. Pooja and Sri H.S.Madappa have not handed over charge, despite the orders of the Chief Executive Officer, ZP, while the other two have not taken any action against the said erring officials. Hence, there is a prima facie case to proceed against the said officials and even the Chief Executive officer, ZP, Davanagere may be made a party. Hence, this is a case for taking up suo-motu cognizance”.

4. In the light of what is stated above, I am prima-facie satisfied that the allegations made in the anonymous petition, which has been investigated by the Superintendent of Police, Karnataka Lokayukta, Davanagere, requires to be treated as source material and the suo-motu proceedings is required to be registered for the purpose of further investigation of the matter. Accordingly, in exercise of the power conferred on me



under Sections 7(1)(b) and 9(3)(b) of the Karnataka Lokayukta Act, 1984, the report given by the Karnataka Lokayukta Police is directed to be treated as source material and suo-motu proceedings is instituted for the purpose of further investigation.

5. The office is directed to register the suo-motu proceedings. For the purpose of further investigation, the following four officers/officials referred to in the report, are directed to be impleaded as Respondents:

Notice may be issued to the Respondents and their comments may be submitted to this office within 10 weeks



from the date of receipt of this order. The office is also directed to implead the **Chief Executive Officer, Zilla Panchayat, Davanagere, as Respondent-5** and issue notice to the **Chief Executive Officer, Zilla Panchayat, Davanagere**, for a limited purpose of conducting the enquiry against the officers/officials referred to above.


6. The **Chief Executive Officer, Zilla Panchayat, Davanagere, Davanagere District is directed to conduct an enquiry** with regard to the report submitted by the Karnataka Lokayukta Police, Davanagere and all other materials collected by the Karnataka Lokayukta Police which are made as part of the report, **within 10 weeks from today.**

7. The report of the Superintendent of Police, Karnataka Lokayukta, Davanagere long with the documents/materials collected by the Lokayukta Police may be forwarded to the Chief Executive Officer, Zilla Panchayat, Davanagere.

8. Further, the Chief Executive Officer, Zilla Panchayat, Davanagere, Davanagere District is directed to take appropriate steps not to settle any of the retirement

benefits payable to Sri. H.S.Madappa, the then First Division Assistant, Zilla Panchayat, Davanagere, till the enquiry is conducted by the Chief Executive Officer, Zilla Panchayat, Davanagere and submit the report to the Lokayukta and until further orders.


