The Deputy Superintendent of Police, Karnataka Lokayukta, Kolar has submitted a report dated 05-12-2018 to Hon'ble Lokayukta, which is referred to the Registrar.

- 2. I have perused the report of the Dy.SP, Karnataka Lokayukta, Kolar. He has indicated about certain deficiencies found at the government hospital, KGF.
- 3. The Dy.SP has reported that the hospital has 220 beds for women and children and also is the hospital for epidemic diseases. Approximately 800 to 1000 patients visit the hospital on each day and at least 75 persons are admitted as inpatients. There is sanctioned strength of 127 staff, but basically only 73 are working. Even the post of District Surgeon is vacant besides that of Paediatrician, Ophthalmologist, Dermatologist, Cardiologist, Anaesthesiologist and physician. 105 'D' group employees, only 34 are working and it has become difficult to keep the hospital clean. He has suggested for increasing the said number.

- 4. From the report of the Dy.SP, Karnataka Lokayukta, Kolar, there is a need of holding an enquiry of the concerned about filling up of vacant posts, increase of number of beds and other facilities detailed hereunder:
 - a) There is a need of filling vacant Physicians, Ophthalmologist, Dermatologist, Cardiologist, and Anaesthesiologist experts immediately;
 - b) There is a need of updating the ICU by providing ventilator and monitor, which are at present not available;
 - c) There is a need of providing digital x-ray instrument;
 - d) There is a need of upgrading the ward of burn injuries and of children;
 - e) There is a need of separate 20 beds for the branch of medicine;
 - f) There are only 4 instruments for dialysis and there is additional need of four more:
 - g) Due to increase in the number of patients visiting the hospital for treatment, there is a need of construction of new rooms;
 - h) There is no air conditioner in blood bank which need to be accommodated;

- k) There is a need of repair of roof of some wards, which are damaged;

- m) The building reserved for women and children is dilapidated and needs immediate repair and upgradation, including compound wall;
- n) The General hospital is located in 15 acres, the hospital for women and children in 10 acres while that of epidemic diseases in 10 acres. But, the constructed area in the total of 35 acres is hardly $10\frac{1}{2}$ acres and therefore huge area is available for formation of a park and there is a need of such park as lung space for the patients and the hospital staff;
- o) There is a need of upgrading the lab;
- p) There is lack of necessary medical equipments pertaining to ENT department at the government hospital, KGF, which may be provided immediately.
- 5. In view of the above report and the need of upgrading the hospital by providing needful

infrastructure for better treatment of poor patients who visit and take treatment at the above said hospitals at KGF, it is requested that your Lordship may kindly take cognizance of the same and kindly issue suitable directions to the concerned.

ORDER

On 04-12-2018, I had visited Government Hospital of KGF, Kolar District along with Additional Director General of Police, Karnataka Lokayukta and local Police attached to Karnataka Lokayukta. I have visited various sections of the Hospital and had a detailed discussion with the Doctors and tried to find out the problems in the hospitals and also with regard to the nature of the health care facilities extended to the ailing patients of the area in the hospital. I had also informed the Karnataka Lokayukta Police, Kolar District to send a detailed report with regard to the functioning of the hospital and patients in the hospital. Accordingly, a report dated 05-12-2018 was submitted by the Deputy Superintendent of Police, Karnataka Lokayukta, Kolar.

2. On receipt of the said report, I had instructed the Registrar, Karnataka Lokayukta, Bengaluru to go through the report and submit a note. Accordingly, the Registrar,

Karnataka Lokayukta, Bengaluru has submitted a note dated 19-01-2019.

3. It is useful to extract the said note, which reads as here under:

"The Deputy Superintendent of Police, Karnataka Lokayukta, Kolar has submitted a report dated 05-12-2018 to Hon'ble Lokayukta, which is referred to the Registrar.

- 2. I have perused the report of the Dy.SP, Karnataka Lokayukta, Kolar. He has indicated about certain deficiencies found at the government hospital, KGF.
- 3. The Dy.SP has reported that the hospital has 220 beds for women and children and also is the hospital for epidemic diseases. Approximately 800 to 1000 patients visit the hospital on each day and at least 75 persons are admitted as inpatients. There is sanctioned strength of 127 staff, but basically only 73 are working. The note submitted by the Registrar on the basis of 4. the report submitted by the Deputy Superintendent of Police. Karnataka Lokayukta, Kolar, depicts several deficiencies in the hospital in various aspects. It is needless to point out that the Government Hospital, KGF has been established several years ago and it caters to the poorer section of the society and the area. KGF is a Taluk Head Quarter and it is an industrial town with large number of labour force, who belong to poorer section of the society. The postings of the staff required in a Taluk Hospital have to be taken care of without further delay. providing staff and Similarly, necessary necessary infrastructure required for a Taluk Hospital and also to the hospital of the nature shall be at KGF cannot be delayed. Therefore, it is needless to point out that the concerned authorities are required to bestow their attention with regard to the deficiencies pointed out in the report, without further delay. It is needless to point out that providing health care is one of the important functions of the state and if there is any deficiency in extending effective and purposeful health care to the public, it would result in



violation of human rights and also right to life and personal liberty guaranteed under Article 21 of the Constitution of India.

5. It is also needless to point out that the Taluk Hospitals are required to possess all the necessary facilities to treat the ailing patients. Non-availability of the facilities to treat the ailing patients in case of serious health problems may seriously affect the right to health and liberty guaranteed under Article 21 of the Constitution of India. Article 47 of Chapter- Directive Principles of state policy of the Constitution also casts an obligation on the state to provide quality health service. It is useful to extract Article 47 of the Constitution of India which reads as under-

"47. Duty of the state to raise the level of nutrition and the standard of living and to improve public health.-

The state shall regard the raising of the level
of nutrition and the standard of living of its people and
the improvement of public health as among its primary



duties and, in particular, the state shall endeavor to bring about prohibition of the consumption except for medicinal purposes of intoxicating drinks and of drugs which are injurious to health".

Under these circumstances I am of the opinion, the authorities of the state are required to bestow their attention to provide in the Government Hospitals at KGF of Kolar District with all facilities required to be extended and to bring such facilities in KGF Hospital in par with the facilities provided in other District Hospitals in the state, which are extending quality health services. It is also needless to point out that poorer section of the people cannot afford to approach the private hospitals for health care facilities and as observed by me earlier depriving reasonable good health care facilities results in depriving of Right to Live, Right to Life and Right to Personal Liberty as guaranteed under Article 21 of the Constitution of India. The report submitted by the Lokayukta Police indicates that the action is required to be taken both for the purpose of redressal and also for remedying the mal-administration.

6. It is also needless to point out that failure to recruit the staff, Doctors and other staff in accordance with the sanctioned strength and providing basic infrastructure facilities required as per the norms laid down amount to mal-administration on the part of the authorities of the State. It may be necessary to examine the matter for taking action for mal-administration with a specific purpose of giving relief to the ailing patients who generally depend upon the government hospitals on account of poverty. It is useful to extract the definition of mal-administration, which reads as here under:

"Section 2(10) " Maladministration" means action
taken or purporting to have been taken in the exercise
of administrative functions in any case where,-

- (a) Such action or the administrative procedure or practice governing such action is unreasonable, unjust, oppressive or improperly discriminatory; or
- (b) There has been willful negligence or undue delay

 in taking such action or the administrative

 procedure or practice governing such involves

 undue delay".



- 7. Therefore, I am of the opinion that the report submitted by the Deputy Superintendent of Police, Karnataka Lokayukta, Kolar, can be considered as source material for the purpose of initiating suo-motu proceedings in exercise of the power conferred on me under Section 7(1)(b) and Section 9(3)(a) of the Karnataka Lokayukta Act, 1984. Accordingly, I exercise the suo-motu power. The office is directed to register this case as suo-motu proceedings.
- 8. For the purpose of investigation, I am of view, that it is in the interest of justice to issue notice and implead the following officers as Respondents:
 - 1. The Principal Secretary to Government, Department of Health & Family Welfare Services, No.105, 1st Floor, Vikasa Soudha, Bengaluru-560 001:
 - 2. The Principal Secretary to Government, Health & Family Welfare Services (Medical Education), M.S.Building, Bengaluru-560 001;
 - 3. The Deputy Commissioner, Kolar, Kolar District;
 - 4. The Commissioner, Health & Family Welfare Services, Ananda Rao Circle, Bengaluru-560 009;

- 5. The Director, Directorate of Health & Family Welfare Services, New Building, Ananda Rao Circle, Bengaluru-560 009.
- 6. The District Surgeon, Kolar, Kolar District;
- 7. The District Health Officer, Kolar District, Kolar.

Accordingly, issue notice to the officers referred to above. along with the copy of the report submitted by the Deputy Superintendent of Police, Karnataka Lokayukta, Kolar, for the purpose of taking remedial measures.

- 9. It is needless to point out that the DHO, Kolar is required to bring to notice of the higher authorities the need of updating the hospitals by remedying the deficiencies pointed out in the report submitted by the Deputy Superintendent of Police, Karnataka Lokayukta, Kolar.
- 10. The officers referred to above are directed to examine the facilities that are available and that are not available in the Government Hospital at KGF of Kolar District and to submit a report on the facilities that are required to be provided to make the hospitals referred to above up to date with all the medical facilities that could be extended to the



ailing patients and also the steps taken to remedy the deficiencies pointed out above. Such examination shall be done and necessary comments/reply shall be submitted to the Lokayukta within 10 weeks from the date of receipt of this order.
