ORDER

Pursuant to the direction given by me to inspect various government offices/institutions (i.e., Revenue Department, Social Welfare Department, Backward Classes Welfare Department, Backward and Minority Hostels) in the district, the Superintendent of Police, Karnataka Lokayukta, Raichur has submitted a report dated 08-09-2017 along with the report dated 29-08-2017 of the Police Inspector, Karnataka Lokayukta, Raichur and photographs, to this office. The report submitted by the Superintendent of Police, Karnataka Lokayukta, Raichur was examined by Assistant Registrar of Legal Opinion-4, Karnataka Lokayukta, Bengaluru (herein after referred to as 'ARLO-4' for short).

2. On the basis of the report submitted by Superintendent of Police, Karnataka Lokayukta, Raichur, the ARLO-4 has submitted a note, which reads as here under:



3. The report submitted by the Superintendent of Police, Karnataka Lokayukta, Raichur and the note submitted by ARLO-4 indicates certain deficiencies in Government Pre-Metric Boys Hostel located at Musarkal Village, Devadurga Taluk. The report indicates the dereliction of duty on the part of the officials who are in charge of managing the hostel. The report submitted by the Superintendent of Police, Karnataka Lokayukta, Raichur may be taken as source material for the purpose of initiating suo-motu powers conferred on me under Section 7(1)(b) and Section 9(3)(a) of the Karnataka Lokayukta Act, 1984. Accordingly, I exercise the suo-motu power. The office is directed to register this case as suo-motu proceedings.

4. As observed by me earlier, the report submitted by the Superintendent of Police, Karnataka Lokayukta, Raichur indicates dereliction of duty on the part of District Social Welfare Officer, Raichur; Taluk Social Welfare Officer, Devadurga Taluk; and Sri Mouneshwar, Supervisor/Warden, Government Pre-Metric Boys Hostel, Musarkal, Devadurga Taluk, Raichur District.

5. The effect of dereliction of duty by the officers referred to above has serious consequences on the comforts of the students who are boarders of the hostel. The hostel is provided by the state for the poorer section of the society with the object of enabling them to get quality education.

Therefore, it is the duty of the concerned officers, who are in charge of managing hostel are required to supervise and to take all precautions to maintain the hostel as per the norms laid down. The report indicates that the same is lacking.

6. It is needless point out that the Respondents 5 to 7 named herein below, who are working in Social Welfare Department have responsibility to effectively utilize sources made available by Government to uplift the weaker section society by taking special care in their educational and economic interest. **Article 46 of the Indian Constitution contained in part IV** mandates the state promote the educational and economic interests of the weaker Section of the people with specific reference to Scheduled Castes and the Scheduled Tribes, and shall protect them from Social injustice and all forms of exploitation.

7. It is useful extract of Article 46 of Constitution of India, which reads as here under;


“ 46. The State shall promote with special care the educational and economic interests of the weaker sections of the people, and, in particular, of the Scheduled Casts and the Scheduled Tribes, and shall protect them from Social injustice and all forms of exploitation”.

8. Therefore, for the purpose of investigation, it is necessary to issue notice and implead the following officers as Respondents:

Musarkal Village, Devadurga Taluk,
Raichur District.

Accordingly, issue notice to the officers referred to above, along with the copy of the report submitted by the Superintendent of Police, Karnataka Lokayukta, Raichur for the purpose of taking remedial measures.

9. Issue notice to the Respondents. The Officers/ Respondents referred to above, are directed to submit their comments within eight weeks from the date of receipt of

this order. In the mean while, they are also directed to take remedial measures with regard to the deficiencies pointed out and to improve the quality of management of the hostel and to submit the status report with regard to the steps taken.

11) It is respectfully submitted that the Commissioner, Urban Development Authority, Raichur submitted that they have not undertaken any of the road widening and the construction of ring road under Raichur Master Plan – 2021. The Commissioner, Urban Development Authority, Raichur is a party to this case and he wrongly filed his report in this case.

12) The Dy.Director, Social Welfare Department, Raichur submitted report and the remedial measures taken by him along with photographs. The Dy.Director, Social Welfare Department, Raichur submitted that:

1. The proposal has been sent for installation of solar water heater to all the hostels in order to provide the hot water to the students.

2. The Asst.Director Grade-II, Social Welfare Department, Jai Durga has submitted that new doors have been fixed to the rooms of the students in the said hostel. The photographs has been placed.

3. The new pipelines has been done in order to provide water to the students residing in the hostel.

4. The total expenditure of each student residing in hostel is at Rs.1,400 per month. As per the Government order no.ಸಂ.ಕಪಇ/258/ಪಕವಿ/2017 ದಿ.17.4.17 and the amended order dated 24.4.17 the full meals will be provided at 2 times i.e. one at the time of going to school and another at leaving the school and entering into the hostel. Later on snacks will be provided to the

students and dinner will be provided to the students. Banana, egg and sweets will be provided twice in a month and non veg food will be provided once in a month to the students. The quality of the food is also good.

5. The toilet rooms have been repaired and the same has been reported by Asst. Director Grade -II of Social Welfare Department.

13) He also produced the photographs of the same.

14) The respondent no.8 also submitted his comemtns and remedial measures report dated 12.3.19 stating the same as that of the Dy. Director, Social Welfare Department, Raichur.

15) The respondent no.1,2,3,4 and 6 has not submitted status report. The notice has been issued and postal acknowledgement has been received as to the service of notice with respect to the respondent no.2,3 and 6.

16) If approved, reminder may be issued to the respondent no.1,2,3,4 and 6 to submit status report by the next date of hearing.
