In continuation of the letter cited at reference, I have been directed by the Hon'ble Lokayukta to request you to carry out the following assignments:

- I. To inspect at least 30% of the Government/General Hospitals within your jurisdiction inclusive of Primary Health Centres and dispensaries and to interact with the working Doctors and other para medical staff of the said hospitals, as well to interact with patients at such hospitals, dispensaries, Primary Health Centres and to verify about providing health care facilities to the patients, meticulously

verify the hygienic and sanitary conditions, building infrastructure and other deficiencies which need to be improved

- II. To visit at least 30% of social welfare hostels, i.e. SC & ST, backward community, minority and Morarji Desai Residential Schools within their jurisdiction
- III. To visit at least 30% of primary/higher primary schools and verify the percentage of attendance of students, verify about extracurricular activities in the schools including sports and entertainment of the children and also about the quality of food provided to the said students/children, and
- IV. To visit at least 30% of Anganawadis and verify the percentage of attendance of students, verify about extracurricular activities in the Anganawadis including sports and entertainment of the children as well about the condition of the buildings of such Anganawadis.

After visiting the above said places, you are directed to submit a detailed report on the following:


- (i) Quality of food supplied to the inmates
- (ii) Hygienic and sanitary conditions
- (iii) Amenities made available to the inmates
- (iv) Building infrastructure condition
- (v) Comfort level of the inmates
- (vi) Percentage of attendance of students in Schools/ Anganawadis, sports, entertainment and extracurricular activities in the Schools/ Anganawadis
- (vii) Any other deficiencies which need to be improved and
- (viii) Any other grievances heard during the visit, which need to be redressed

As directed, you are also requested to ensure that whenever ladies hostels are visited, **only a lady Police Officer shall pay a visit accompanied by other lady police staff of Karnataka Lokayukta.**

I have also been directed to request you to submit a report preferably within eight weeks from the date of receipt of this communication.
