Sir,

I am directed by the Hon'ble Lokayukta to instruct you the following:

(1) Since it has come to the notice of the Hon'ble Lokayukta in respect of large number of schemes framed by the Government which is meant for the benefit of the people of the State, there has been inordinate delay in reaching benefits of the schemes to the beneficiaries and instead of genuine beneficiaries the benefits are being extended to the persons who are not entitled for the schemes as beneficiaries and there are various other types of mismanagement in the implementation of the schemes including delay on account of various reasons which amounts to maladministration within the meaning of Section 2(10) of Karnataka Lokayukta Act, 1984 (hereinafter referred to as 'the Act').

Therefore, you may kindly find out which of the schemes in your district are misused and has resulted in maladministration and through your officers (police) get the matters verified/examined regarding the delay, willful negligence, etc. which amounts to maladministration pointed out above in implementation of the schemes.

(2) It has also come to the notice of the Hon'ble Lokayukta that there is a tendency on the part of some officials demanding illegal gratification from the public who are coming for facilities/services and for redressal of their grievances like admission to educational institutions, improper functioning of educational institutions, lack of prompt attendance of teachers, etc. management of Anganawadi Institutions, in all types of Government hostels, in Revenue Department, in Forest Department, Social Welfare Department etc., which again amounts to maladministration within the meaning of Section 2(10) of Karnataka Lokayukta Act, 1984.

In this connection, you are requested to depute officers to get the matters discreetly enquire into and identify the person/persons who are indulging in improper conduct responsible for maladministration, so that effective remedial measures may be taken with the assistance of ACB/jurisdictional police and by reporting matter to the higher officers who are in charge of the various departments, for appropriate action.

(3) The Government of Karnataka has also fixed the time limit under 'Sakaala' for implementation of the each one of the scheme sponsored

by the Government, and you may kindly get the matter examined/verified, whether the time fixed for the scheme are adhered to and if it is not adhered, the reasons for such delay/lapses and the person/persons who are responsible for such delay/lapses.

(4) Further, Hon'ble Lokayukta has also directed me to solicit your unstinted co-operation and support in rooting out the corruption, maladministration, dishonesty and indifference in discharging of the duties by the officers/officials of the various departments and you are further informed to convey the contents of this letter in proper perspective and spirit to all the concerned so that remedial measures are more effectively taken before any official action is resorted to by the Hon'ble Lokayukta against erring officials.

(5) You are also requested to coordinate with the various heads of the departments/officers in the District and seek their cooperation and support and through them make serious efforts to take effective remedial measures to root out corruption, maladministration in executing the work by the concerned offices in the administration.

Certain matters which are required to be kept confidential may be communicated by marking it as 'confidential' or over the phone personally to me or to the Hon'ble Lokayukta.


I am also directed to request you to send the progress made with regard to the instructions given above once in a month to the
